I bring proven expertise in digital policy, cybersecurity oversight, and multistakeholder governance, with board-level contributions across the technology, telecommunications, and internet infrastructure sectors.

Previously served as Treasurer and Board Member of **CENTR** (European Association of Country-Code Registries), a member of the **UN Internet Governance Forum's** Multistakeholder Advisory Group (MAG), and as both a board member and **CEO** of **RNIDS** (Serbian National Internet Domain Registry).

As a tech entrepreneur, I founded and scaled multiple ventures, including one of Serbia's first ISPs (SezamPro, with successful exit to Orion Telekom) and the country's leading PC brand (Jugodata). Growing these businesses to leadership positions in the Serbian market equipped me with deep operational insight into innovation, business scaling, and managing disruption.

Currently a **PhD candidate** in economics, holding an **MBA**, and having completed executive education in board governance, strategy, and cybersecurity at **INSEAD**, **Harvard Business School**, **Carnegie Mellon**, and **ESMT Berlin**. I also hold directorship certifications from INSEAD and the National Association of Corporate Directors (**NACD**).

As a frequent public speaker and mentor, I advise startups and senior managers on governance, cybersecurity, and digital development.
